Notification of the merger of companies Altran Technologies Czech Republic, s.r.o. and KON, s.r.o. with SWELL, a.s., and of subsequent corporate name change.

Dear business partners,

We would like to inform you that, as a consequence of Altran Technologies Czech Republic, s.r.o. becoming the sole shareholder of SWELL, a.s. in November 2016 and subsequent consolidation of activities, a merger of the two companies is currently occurring.

As of January 1st 2018, Altran Technologies Czech Republic, s.r.o with registered offices at Českobratrské náměstí 1392, Mladá Boleslav II, 293 01 Mladá Boleslav, IČO: 24263401 and KON, s.r.o. with registered offices at Jiřího z Poděbrad 236, 508 01 Hořice, IČO: 47540214 will cease to exist as separate entities and will be merged with SWELL, a.s. with registered offices at Příčná 2071, Libonice, 508 01 Hořice, IČO: 02673703.

As a result of the merger and as dictated by law, all assets, rights, obligations, receivables and debts arising from business and contractual relations of companies Altran Technologies Czech Republic, s.r.o and KON, s.r.o will be transferred onto the company SWELL, a.s., the universal legal successor to the two companies.

The successor company will take over all of the entrepreneurial, business and research activities of Altran Technologies Czech Republic, s.r.o., and KON, s.r.o and ensure their continuous fulfillment, together with the fulfillment of their existing business plan. Moreover, all employees of the companies will also be transferred to the successor company and the fulfillment of contracts concluded by both companies will not be impaired and will proceed smoothly under the agreed terms and conditions. The successor company is fully prepared to meet all the obligations of Altran Technologies Czech Republic, s.r.o. and KON, s.r.o..

The successor company, SWELL, a.s., will also change its name to ‚Altran CZ a.s.‘ at the effective date of the merger, i.e. January 1st 2018. The registered office of the company as well as its IČO will remain unchanged.

The successor company will become your new business partner and effective as of 1.1.2018, will have the following identification details:
